**ON MONDAY, OCTOBER 2, 2017 AT APPROXIMATELY 10:00 P.M., WINNEBAGO COUNTY SHERIFF'S DETECTIVES AND LOVES PARK POLICE DETECTIVES WERE CONDUCTING SURVEILLANCE ON BURGLARY SUSPECTS AND OBSERVED TWO PERSONS ENTER A DUPLEX LOCATED AT THE 9400 BLOCK OF ROMELDALE LANE IN ROSCOE.**

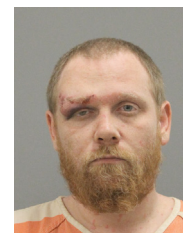
