SHERIFF GARY CARUANA ANNOUNCES THAT DUE TO THE RECENT BUDGET CUTS FACING THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT, TODAY APPROXIMATELY 80 EMPLOYEES ARE IN THE PROCESS OF RECEIVING LAYOFF NOTICES.

LAYOFF NOTICES ARE BEING GIVEN TO APPROXIMATELY 64 PART TIME RESERVE DEPUTIES WHO'S MAIN FUNCTION HAS BEEN TO PROVIDE COURTHOUSE SECURITY. THE LAST DAY FOR THESE RESERVE OFFICERS IS OCTOBER 20TH, 2017. APPROXIMATELY 10 PATROL DEPUTIES FROM OTHER AREAS WITHIN THE SHERIFF'S DEPARTMENT WILL BE REASSIGNED IN AN EFFORT TO MAINTAIN COURTHOUSE SECURITY.

SHERIFF CARUANA ALSO SERVED NOTICE TO 10 CORRECTIONS OFFICERS AS WELL AS OTHER EMPLOYEES OF THE LAYOFF WHICH WILL TAKE EFFECT ON OCTOBER 26TH, 2017.

SHERIFF CARUANA STRESSED THAT THE CITIZENS OF WINNEBAGO COUNTY ARE SAFE, AND THAT THIS PORTION OF THE LAYOFFS WILL REMEDY SOME OF THE MORE THAN \$4 MILLION DOLLAR CUT THAT WAS GIVEN TO HIS DEPARTMENT.
