EFFECTIVE OCTOBER 23, 2017 DUE TO SAFETY CONCERNS AND RECENT BUDGET CUTS, BAGS OF ANY TYPE WILL NOT BE ALLOWED INTO THE WINNEBAGO COUNTY COURTHOUSE. CERTAIN TYPES OF BAGS MAY BE ALLOWED THAT HOLD MEDICAL SUPPLIES, DIAPER BAGS, ETC. AND WILL BE EVALUATED ON A CASE BY CASE BASIS.

SOMEONE THAT ARRIVES TO ONE OF THE COURT BUILDINGS WITH A PROHIBITED BAG WILL NOT BE ALLOWED INTO THE COURTHOUSE WITH THAT BAG. WE WILL NOT PROVIDE A PLACE TO STORE THE BAG WHILE SOMEONE IS IN COURT.

LONGER LINES AT THE SCANNERS CAN BE EXPECTED, SO PLEASE ARRIVE IN ENOUGH TIME TO GO THROUGH SCREENING. PROHIBITING BAGS SHOULD SPEED UP THIS PROCESS.

IN ADDITION, THE FOLLOWING ITEMS HAVE ALWAYS BEEN PROHIBITED IN THE COURT BUILDINGS AND SHOULD BE LEFT AT HOME.
