On Saturday November 11th, 2017, Winnebago County Sheriff's deputies were sent to a local restaurant in the area of Harrison Av & Stowmarket Av in Rockford IL. A call was received from an On Duty Boone County Sheriff's deputy who had been alerted to a suspicious situation from the restaurant worker.

Upon arrival Sheriff's deputies met with the Boone County sheriff's deputy who had a subject detained in the parking lot. This subject was identified as (Darryl E Ross,/ Male, (02/26/1983)

The investigation revealed that Darryl Ross had entered a drive thru food line and ordered food. Ross then drove up to the window to pick up the food. The worker started to hand Ross the food when Ross stated he was paying her for the food in drugs. Ross then handed the worker a plastic baggy containing with 4 small baggies each containing an off white rock substance. The worker took the baggy but did not give Ross the food. The worker immediately contacted the Boone Sheriff's deputy who was in the restaurant at the time and notified him of the situation.

Ross was detained in the parking lot of the restaurant and after a subsequent search, Sheriff's Deputies recovered 7 Baggies of an off white rock substance (Tested Positive for presence Cocaine) and two baggies of Brown substance. (Tested positive for presence of Heroin) The 4 Baggies handed to the worker (Tested Positive for the presence of Cocaine.)

Ross was lodged in the Winnebago County Jail charged with Possession with intent to Deliver 1-15 grams of cocaine, Possession of controlled substance (Cocaine) and Possession controlled substance (Heroin) Bond \$ 50,000.00

The charges against Darryl E Ross are merely accusations and he is considered innocent until proven guilty in a court of law.
