On Tuesday, November 28, 2017, the Winnebago County Sheriff's Narcotics Unit were conducting a narcotics investigation in the area of 20<sup>th</sup> St. and Harrison and observed a narcotics transaction. The Unit stopped the suspected dealer who was arrested for delivering 2 grams of crack cocaine. The investigation led to the 2000 block of Rexford Lane in Rockford. The Unit conducted surveillance and stopped another dealer who was found to be in possession of 2.5 grams of crack and .2 grams of heroin. A search of the residence led to the recovery of an additional 81 grams of crack cocaine and 10 grams of heroin, along with 2 handguns, one of which was found to be stolen out of Rockford. It was learned through the investigation that the two were father and son, living in two residences, across the street from each other in the 2000 block of Rexford Lane. The Unit arrested, lodged and charged the following persons:

**-Delivery of a Controlled Substance (Cocaine) 1-15 grams**

**~Demarko D. Parker 6/10/91 of Rockford**

**-Unlawful Use of a Weapon by a Felon**

**-Possession of a Stolen Firearm**

**-Possession with Intent to Deliver Cocaine 1-15 grams**

**-Possession with Intent to Deliver Heroin < 1 gram**

**-Possession with Intent to Deliver Cocaine 15-100 grams**

**-Possession with Intent to Deliver Heroin 1-15 grams**

The charges against Newble and Parker are merely accusations and they are considered innocent until proven guilty in a court of law.
