On Thursday, January 11, 2018, Winnebago County Sheriff's Deputies responded to the Mobil gas station, 8200 N. Second St. in Machesney Park at approximately 3:15 a.m. for an Armed Robbery. The on duty clerk was approached by a white male wearing a bandana or mask covering part of his face and armed with a handgun, demanding money. The suspect fled from the store on foot with an undisclosed amount of currency.

On Saturday, January 13, 2018, Winnebago County Sheriff's Detectives identified the suspect and obtained an arrest warrant for the suspect.

On Tuesday, January 16, 2018, Winnebago County Sheriff's Detectives, Loves Park Detectives and members of the FBI Safe Streets Task Force located the suspect in the 8400 block of Elm St., Machesney Park, and took the suspect into custody on the robbery arrest warrant.
