**ON FRIDAY, JANUARY 26, 2018, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT ARRESTED BRANDON D. BARNES IN THE 600 BLOCK OF KISHWAUKEE STREET. THIS WAS THE CULMINATION OF A SHORT TERM NARCOTICS INVESTIGATION INVOLVING THE PURCHASE OF COCAINE FROM BRANDON D. BARNES. THE INVESTIGATION LED TO A SEARCH OF A RESIDENCE IN THE 400 BLOCK OF FITCH ROAD WHERE MORE COCAINE AND FIREARM AMMUNITION WERE LOCATED. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

- ~BRANDON D. BARNES (D.O.B. 4/4/82) OF ROCKFORD.**
- DELIVERY OF COCAINE 15-100 GRAMS**
- POSSESSION WITH INTENT TO DELIVER COCAINE 1-15 GRAMS**
- POSSESSION OF AMMUNITION WITHOUT REQUISITE FIREARM OWNER'S ID CARD**

**THE CHARGES AGAINST BRANDON D. BARNES ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.**
