On Saturday, February 10, 2018, at approximately 4:00 p.m., a Winnebago County Sheriff's Deputy attempted to stop a vehicle for a traffic violation at N. Bell School Rd. @ Potawatami Dr. The offending vehicle fled from the Deputy and immediately crashed into a median, flattening both front tires. The vehicle continued to flee from the Deputy at a slow rate of speed and disobeyed the traffic control device at E. State St. @ Perryville Rd. where it was struck by a northbound vehicle.

Two of the three occupants fled the scene on foot and were apprehended a short distance away behind a business by a Rockford Police Officer. The remaining occupant of the offending vehicle was taken into custody at the scene. The occupants of the non-offending vehicle were not injured and the damage to both cars was minimal.

Inside of the offending vehicle, Deputies located 3.1 grams of heroin. All three occupants of the offending vehicle were arrested, charged and lodged in the Winnebago County Jail:

- Possession with Intent to Deliver Heroin (1-15 grams)**

The charges against Dickens, Hurd and Parchman are merely accusations and they are presumed innocent until proven guilty in a court of law.
