On Monday, February 12, 2018, the Winnebago County Sheriff's Narcotics Unit executed a search warrant in the 2700 block of 21<sup>st</sup> Avenue in Rockford. The unit recovered 33.6 grams of cocaine, 513 grams of cannabis, two hand guns and over \$4,300 in United States Currency. The homeowner was arrested, charged and lodged in the Winnebago County Jail. Arrested was:

**~Miguel A. Castelan Jr. 6/27/91 of Rockford**

- Possession with Intent to Deliver Cocaine (15-100 grams)**
- Possession with Intent to Deliver Cannabis (500-2000 grams)**
- Armed Violence**
- No FOID**

The charges against Castelan are merely accusations and he is presumed innocent until proven guilty in a court of law.
