**ON FRIDAY, FEBRUARY 23, 2018, AT APPROXIMATELY 9:00 A.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT EXECUTED A SEARCH WARRANT IN THE 2200 BLOCK OF CANARY DRIVE IN ROCKFORD, ILLINOIS. DURING THE EXECUTION OF THE SEARCH WARRANT, DEPUTIES LOCATED CRACK COCAINE AND A LOADED HANDGUN. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

- ~MARKIEZ K. LACY (09/05/87) OF ROCKFORD.**
- POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 GRAMS)**
  - UNLAWFUL USE OF WEAPONS BY A FELON**
  - POSSESSION OF AMMUNITION WITHOUT REQUISITE FIREARM OWNER'S ID CARD**
  - ARMED VIOLENCE**
