ON FRIDAY, MARCH 2ND, 2018, AT APPROXIMATELY 12:15 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT EXECUTED A SEARCH WARRANT IN THE 500 BLOCK OF SOUTH GREENVIEW AVENUE IN ROCKFORD, ILLINOIS. DURING THE EXECUTION OF THE SEARCH WARRANT, DEPUTIES LOCATED HEROIN AND CRACK COCAINE IN THE RESIDENCE. THE INVESTIGATION CONTINUED TO THE 2600 BLOCK OF KAREN DRIVE IN ROCKFORD WHERE MORE CRACK COCAINE WAS LOCATED. THE FOLLOWING INDIVIDUALS WERE ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- POSSESSION WITH INTENT TO DELIVER HEROIN (1-15 GRAMS)
- POSSESSION WITH INTENT TO DELIVER COCAINE (15-100 GRAMS)
