ON MONDAY, APRIL 16, 2018, AT APPROXIMATELY 9:00 A.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT EXECUTED A SEARCH WARRANT IN THE 2400 BLOCK OF ELM STREET IN ROCKFORD, ILLINOIS. DURING THE EXECUTION OF THE SEARCH WARRANT, DEPUTIES LOCATED OVER 400 ECSTASY PILLS AND A LOADED HANDGUN WHICH HAD AN OBLITERATED SERIAL NUMBER. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- ~TOMMY D. STANLEY (02/20/80) OF ROCKFORD.
- POSSESSION WITH INTENT TO DELIVER ECSTASY (400-600 PILLS)
- UNLAWFUL USE OF WEAPONS BY A FELON
- POSSESSION OF FIREARM WITH DEFACED SERIAL NUMBER
- ARMED VIOLENCE
