**ON THURSDAY, APRIL 26, 2018 AT APPROXIMATELY 4:15 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT, ALONG WITH SHERIFF'S DEPARTMENT DETECTIVES, ARRESTED ANTHONY J. HILL IN THE 2400 BLOCK OF NORTH ROCKTON AVENUE. HILL WAS WANTED ON AN ARREST WARRANT FOR AGGRAVATED BATTERY TO A POLICE OFFICER. MEMBERS OF THE SHERIFF'S DEPARTMENT WERE IN THE AREA TRYING TO LOCATE HILL WHEN THEY OBSERVED HIM CONDUCT A NARCOTICS TRANSACTION. HE WAS TAKEN INTO CUSTODY SHORTLY THEREAFTER AND, LOCATED IN HILL'S VEHICLE, WAS AN AMOUNT OF MARIJUANA AND ECSTASY. HILL IS CURRENTLY ON PAROLE FOR ARMED ROBBERY. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**
