ON WEDNESDAY, MAY 2, 2018, AT APPROXIMATELY 1:20 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT EXECUTED A SEARCH WARRANT IN THE 900 BLOCK OF KENT STREET IN ROCKFORD, ILLINOIS. DURING THE EXECUTION OF THE SEARCH WARRANT, DEPUTIES LOCATED COCAINE, MARIJUANA PACKAGED FOR SALE, A MARIJUANA GROWING OPERATION, AND A HANDGUN. - POSSESSION OF FIREARM WITHOUT REQUISITE FIREARM OWNER'S ID CARD**
