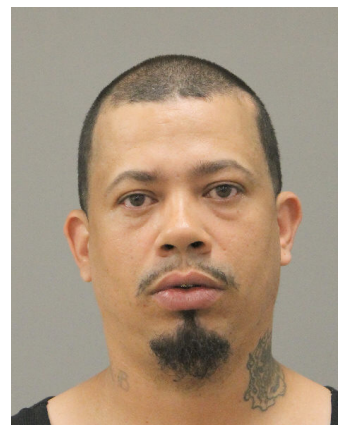

ON MONDAY, MAY 7, 2018, AT APPROXIMATELY 3:00 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT WAS CONDUCTING A NARCOTICS INVESTIGATION IN THE 1000 BLOCK OF OAKLEY AVENUE. DEPUTIES OBSERVED A SUBJECT, IDENTIFIED AS CHARLES GHOLSON, CONDUCT A NARCOTICS TRANSACTION AND, AFTER A SHORT FOOT PURSUIT, HE WAS TAKEN INTO CUSTODY. GHOLSON WAS FOUND TO HAVE AN AMOUNT OF HEROIN ON HIS PERSON. THIS INVESTIGATION LED TO A SEARCH OF A RESIDENCE IN THE 1000 BLOCK OF OAKLEY AVENUE WHERE MORE HEROIN AND CRACK COCAINE WERE LOCATED. GHOLSON WAS ON PAROLE FOR INTIMIDATION OF A WITNESS AND WAS WEARING AN ELECTRONIC MONITORING ANKLE BRACELET. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- ~CHARLES N. GHOLSON (12/6/82) OF ROCKFORD.**
- POSSESSION WITH INTENT TO DELIVER HEROIN (15-100 GRAMS)**
 - POSSESSION WITH INTENT TO DELIVER COCAINE (1-15 GRAMS)**
 - DELIVERY OF LESS THAN ONE GRAM OF HEROIN**
 - RESISTING A PEACE OFFICER**
 - DEPARTMENT OF CORRECTIONS PAROLE VIOLATION**
