ON SUNDAY, MAY 13TH 2018 AT APPROXIMATELY 4:55 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT WAS DISPATCHED TO A SINGLE VEHICLE CRASH ON IL ROUTE 2 JUST SOUTH OF ROSCOE RD. A DEPUTY ARRIVED ON-SCENE TO FIND A BLUE, 2001 DODGE PICK UP TRUCK OFF THE EAST SIDE OF THE ROADWAY RESTING ON THE PASSENGER SIDE OF THE VEHICLE. THE VEHICLE WAS TRAVELLING NORTH ON IL. RT. 2 AND LEFT THE ROADWAY ON THE EAST SIDE OF THE ROAD AND HIT A TREE. THE DRIVER, A 39-YEAR OLD FEMALE WAS THE ONLY OCCUPANT OF THE VEHICLE. THE FEMALE WAS AIRLIFTED TO A LOCAL HOSPITAL. THE FEMALE WAS PRONOUNCED DEAD AT THE HOSPITAL. THE IDENTITY OF THE FEMALE WILL BE RELEASED BY THE WINNEBAGO COUNTY CORONER AFTER THEY NOTIFY NEXT OF KIN. THE INVESTIGATION IS ONGOING AND THERE IS NO FURTHER INFORMATION AT THIS TIME.
