DUE TO RECENT SIGNIFICANT RAINFALL WINNEBAGO COUNTY SHERIFF GARY CARUANA HAS ISSUED A TEMPORARY NO WAKE ORDER FOR THE ENTIRE ROCK RIVER IN WINNEBAGO COUNTY UNTIL FURTHER NOTICE.

ACCORDING TO THE NATIONAL WEATHER SERVICE THE ROCK RIVER IN WINNEBAGO COUNTY IS UNDER A FLOOD ADVISORY. THE FLOOD ADVISORY CONTINUES FOR THE ROCK RIVER AT LATHAM PARK UNTIL FRIDAY EVENING. * AT 915 AM WEDNESDAY THE STAGE WAS 8.8 FEET. * ACTION STAGE IS 9.0 FEET AND FLOOD STAGE IS 10.0 FEET. THE RIVER WILL RISE TO NEAR 9.2 FEET AT LATHAM PARK BY THURSDAY MORNING BEFORE RECEDING. THE FLOOD ADVISORY ALSO COVERS THE ROCK RIVER AT ROCKTON UNTIL FRIDAY AFTERNOON. AT 930 AM WEDNESDAY THE STAGE WAS 8.4 FEET. ACTION STAGE IS 8.5 FEET.

FLOOD STAGE IS 10.0 FEET. THE RIVER WILL RISE TO NEAR 8.7 FEET BY THIS EVENING AT ROCKTON BEFORE RECEDING.

A FLOOD ADVISORY FOR THE KISHWAUKEE RIVER NEAR PERRYVILLE IS ALSO IN EFFECT UNTIL LATE TONIGHT. AT 930 AM WEDNESDAY THE STAGE WAS 11.6 FEET. ACTION STAGE IS 11.5 FEET. FLOOD STAGE IS 12.0 FEET. FORECAST...THE RIVER WILL RISE TO NEAR 11.7 FEET BY THIS AFTERNOON. IMPACT AT 12.0 FEET IS CHERRY VALLEY CITY PARK FLOODS. THE SHERIFF'S OFFICE CONTINUES TO MONITOR RIVER LEVELS.
