ON FRIDAY, AUGUST 3, 2018, AT APPROXIMATELY 8:12 P.M., WINNEBAGO COUNTY SHERIFF'S DEPUTIES WERE DISPATCHED TO A RESIDENCE IN THE 6600 BLOCK OF HALLEY ROAD FOR A DOMESTIC DISTURBANCE. WHILE INVESTIGATING THE DOMESTIC DISTURBANCE, DEPUTIES LOCATED A MARIJUANA GROWING OPERATION AT THE RESIDENCE. DEPUTIES LOCATED 60 MARIJUANA PLANTS, AND OVER 7,000 GRAMS OF MARIJUANA THROUGHOUT THE RESIDENCE. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:
