ON 08/08/18 AT 0033 HOURS DEPUTIES WERE IN THE AREA OF 20TH ST AND 7TH AVE WHEN THEY HEARD POLICE RADIO TRAFFIC FROM ROCKFORD POLICE OFFICERS SAY THEY HAD A BLACK NISSAN ALTIMA FLEE FROM THEM AND IS A SUSPECT VEHICLE IN THE SHOOTING OF A JUVENILE MALE THAT JUST HAPPENED IN THE 2100 BLOCK OF 25TH ST EARLIER AT 2327 HOURS.

WINNEBAGO COUNTY SHERIFF'S DEPUTIES TRIED TO STOP THE SUSPECT VEHICLE AT 20TH ST AND 7TH AVE. THE VEHICLE FAILED TO STOP AND THE DEPUTIES PURSUED THE VEHICLE UNTIL IT STOPPED AT WINDSOR RD AND BLACKBERRY KNOLL RD BECAUSE OF MECHANICAL ISSUES. A PASSENGER FLED THE VEHICLE AND WAS CAUGHT BY A WINNEBAGO COUNTY SHERIFF'S DEPUTY IN THE 4400 BLOCK OF BLACKBERRY KNOLL AFTER A SHORT FOOT PURSUIT. THREE OTHER SUSPECTS WERE TAKEN INTO CUSTODY. A LOADED HANDGUN WAS RECOVERED. THE ROCKFORD POLICE DEPARTMENT IS STILL INVESTIGATING THE SHOOTING INCIDENT.

THE FOLLOWING SUSPECTS WERE ARRESTED:

- 1- A 17 YEAR OLD MALE JUVENILE FROM ROCKFORD, IL**
 - FOR AN ACTIVE WINNEBAGO COUNTY ARREST WARRANT AND OBSTRUCTING IDENTIFICATION**
- 2- MONTRIEL D. CLARK (07-12-1998) OF ROCKFORD, IL**
 - AGGRAVATED FLEEING TO ELUDE A POLICE OFFICER**
 - NO VALID DRIVER'S LICENSE**
 - RESISTING/OBSTRUCTING A PEACE OFFICER**
- 3- KESHAUN M. JONES (11-06-1999) OF ROCKFORD, IL**
 - 3 COUNTS OF AGGRAVATED UNLAWFUL USE OF WEAPONS**
 - NO VALID FOID CARD**
 - ILLEGAL POSSESSION OF AMMUNITION**
 - RESISTING/OBSTRUCTING A PEACE OFFICER**

THE CHARGES AGAINST THE ACCUSED ARE MERELY ACCUSATIONS AND THEY ARE PRESUMED INNOCENT UNTIL PROVEN GUILTY IN THE COURT OF LAW.
