INFORMATION: POSSESSION OF A STOLEN VEHICLE/RESIDENTIAL BURGLARY

On Friday, August 10, 2018 at approximately 4:00 a.m., Winnebago County Deputies were dispatched to the area of River Keys estates in Machesney Park for several burglary to vehicle incidents that occurred overnight.

A Sheriff's Deputy located a suspicious vehicle parked in a driveway in the 6700 block of Key Largo Dr. The Deputy located a female in the passenger seat of a vehicle that was reported stolen out of Indiana. The plates on the vehicle also returned stolen out of Chicago.

Another Deputy obtained information of a black male with dreadlocks carrying a black bag running from the area. Deputies, with the assistance of the Loves Park Police Department set up a perimeter until a Winnebago County Sheriff's K9 arrived to conduct a track.

The Sheriff's K9, "Chico" began a track into a thick wooded area along the railroad tracks off of Bergstrom Rd. where the suspect was seen running from Deputies. After a short foot pursuit through the woods, the suspect was captured in a field near Old River Rd.

K9 "Chico" conducted an article search of the area the suspect was seen and located a black bag containing stolen property which matched several area Burglary from Vehicle incidents and two Residential Burglaries.

After Winnebago County Detectives interviewed the suspects, both were lodged in the Winnebago County Jail, charged with the following:

~Darvis R. Dennis 3/12/88 of Chicago

- Residential Burglary (2 counts)**
- Aggravated Resisting Arrest**
- Possession of Stolen License Plates**
- Possession of a Stolen Vehicle**

~Izalis Morales 6/4/99 of Chicago

- Criminal Trespass to Vehicle**

The charges against Dennis and Morales are merely accusations and they are considered innocent until proven guilty in a court of law.
