On Wednesday, August 29, 2018 at approximately 1:30 p.m., a Winnebago County Sheriff's Deputy made a traffic stop on Preston St. at Trenton Ave. A passenger of the car immediately fled on foot and was observed holding a handgun. The fleeing suspect was pursued, last seen on the grounds of Dennis School on Lincoln Park Blvd.

Responding Deputies made contact with school officials at Dennis School which was placed on lockdown for safety reasons. The suspect did not enter the school and Deputies remained at the school while a perimeter was set up by other Deputies and Detectives.

Winnebago County K9 teams responded to the area and began tracking the suspect who was subsequently located in a field at Springfield Ave. and Cunningham Rd. The suspect was taken into custody without further incident and a loaded 9 mm handgun was recovered.

The driver of the vehicle was cited and released and the fleeing passenger was arrested and lodged:
