**On Friday Feb 1, 2019 at approximately 0730 hrs, a sprinkler head burst in the ceiling of the Winnebago County Criminal Justice Center lobby located at 650 W. State St, Rockford, Il.**

**The Rockford Fire department along with Winnebago County Maintenance personnel responded and shut the water off in the system. The incident appears to be weather related.**

**At this time, the lobby of the Justice Center is closed and all court appearances that were scheduled to be held at the Justice Center have been moved to the Winnebago County Courthouse at 400 West State St.**

**Cleanup efforts will continue with the possibility that the afternoon court call scheduled for the Justice center will be held and the building reopened.**

**There is no dollar estimate at this time of the damage.**
