**ON THURSDAY MAY 2, 2019, AT APPROXIMATELY 8:30 A.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT, AND THE STATE LINE AREA NARCOTICS TEAM, CONDUCTED A NARCOTICS INVESTIGATION IN THE 4700 BLOCK OF CARTHAGE DRIVE. DURING THE COURSE OF THIS INVESTIGATION, DYLAN M. BRYANT FROM ROCHELLE, ILLINOIS, WAS LOCATED AND AN AMOUNT OF COCAINE WAS LOCATED ON HIS PERSON. FOLLOW UP INVESTIGATION WAS CONDUCTED AT A RESIDENCE IN THE 400 BLOCK OF SOUTH MAIN IN ROCHELLE AND SUSPECTED COCAINE, MARIJUANA, AND PSILOCYBIN MUSHROOMS WERE LOCATED. BRYANT IS CURRENTLY ON PAROLE FROM THE ILLINOIS DEPARTMENT OF CORRECTIONS FOR A PREVIOUS NARCOTICS VIOLATION. THE CHARGES IN OGLE COUNTY ARE PENDING AT THIS TIME. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

-POSSESSION WITH INTENT TO DELIVER COCAINE 1-15 GRAMS**
