FOR THE PAST SEVERAL WEEKS, THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT HAS BEEN RECEIVING COMPLAINTS FROM CONCERNED CITIZENS REGARDING THE SALES OF NARCOTICS IN THE 900 BLOCK OF WEST STREET. AFTER A SHORT INVESTIGATION, THE RESIDENCE WAS IDENTIFIED AND A SEARCH WARRANT WAS OBTAINED. ON THURSDAY, MAY 30, 2019, AT APPROXIMATELY 2:15PM., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT EXECUTED THE SEARCH WARRANT AND LOCATED AN AMOUNT OF CRACK COCAINE AND FIREARM AMMUNITION. THE WINNEBAGO COUNTY STATES ATTORNEY'S OFFICE REVIEWED THE FACTS OF THE CASE AND AUTHORIZED THE FOLLOWING CHARGES AGAINST THE RESIDENT, JUDY AGUAYO:

-POSSESSION WITH INTENT TO DELIVER COCAINE (1-15GRAMS)

-POSSESSION OF AMMUNITION WITHOUT REQUISITE FIREARM OWNER'S ID CARD
