**ON THURSDAY, JULY 11, 2019, AT APPROXIMATELY 6:25 P.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT, AND THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT TAC TEAM, CONDUCTED A NARCOTICS INVESTIGATION IN THE AREA OF FURMAN STREET AND ASHLAND AVENUE. THIS INVESTIGATION WAS CONDUCTED DUE TO A COMPLAINT OF NARCOTICS BEING SOLD IN THE AREA. A VEHICLE WAS OBSERVED IN THE AREA AND, AS OFFICERS APPROACHED THE VEHICLE, THE DRIVER EXITED THE VEHICLE AND RAN. A FOOT CHASE ENSUED AND THE DRIVER, DYLAN D. BROWN, WAS TAKEN INTO CUSTODY. INSIDE OF THE VEHICLE, DEPUTIES LOCATED HEROIN AND A LARGE AMOUNT OF COCAINE.**

**THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:**

- ~DYLAN D. BROWN (D.O.B. 05/08/93) OF ROCKFORD, ILLINOIS.**
- POSSESSION WITH INTENT TO DELIVER COCAINE 100-400 GRAMS**
- POSSESSION WITH INTENT TO DELIVER HEROIN 1-15 GRAMS**
- OBSTRUCTING A PEACE OFFICER-INJURY**
