ON THURSDAY, OCTOBER 10, 2019, AT APPROXIMATELY 2:00 P.M., MEMBERS OF THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT WERE CONDUCTING A NARCOTICS INVESTIGATION IN THE 400 BLOCK OF NORTH HENRIETTA AVENUE. THIS INVESTIGATION WAS CONDUCTED DUE TO CITIZEN COMPLAINTS OF NARCOTICS DEALING IN THE NEIGHBORHOOD. THEY LOCATED CHARLES K. SIMPSON IN THE AREA WHO WAS FOUND TO BE IN POSSESSION OF OVER 50 GRAMS OF COCAINE. THE FOLLOWING INDIVIDUAL WAS ARRESTED AND LODGED IN THE WINNEBAGO COUNTY JAIL:

- ~CHARLES K. SIMPSON (02/04/70) OF ROCKFORD.**
- POSSESSION WITH INTENT TO DELIVER COCAINE 15-100 GRAMS**
- DELIVERY OF COCAINE 15-100 GRAMS**

THE CHARGES AGAINST CHARLES K. SIMPSON ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
