ON MONDAY, OCTOBER 28, 2019, AT APPROXIMATELY 11:00 A.M., THE WINNEBAGO COUNTY SHERIFF'S DEPARTMENT NARCOTICS UNIT WERE CONDUCTING A NARCOTICS INVESTIGATION IN THE AREA OF BROADWAY STREET AND REMINGTON ROAD. DURING THIS INVESTIGATION, A SUSPECTED NARCOTICS TRANSACTION WAS OBSERVED. DEPUTIES WERE ABLE TO FOLLOW THE SUSPECT VEHICLE TO THE AREA OF HARRISON AND ALPINE WHERE THEY TOOK THE SUBJECT, CHRISTOPHER TOLLIVER, INTO CUSTODY. WHEN DEPUTIES MADE CONTACT WITH TOLLIVER, A 2 YEAR OLD CHILD WAS IN HIS LAP, UNRESTRAINED. DEPUTIES ALSO LOCATED COCAINE WITHIN THE VEHICLE. THE WINNEBAGO COUNTY STATES ATTORNEY'S OFFICE REVIEWED THE FACTS OF THE CASE AND AUTHORIZED THE FOLLOWING CHARGES AGAINST CHRISTOPHER TOLLIVER:

- ~CHRISTOPHER G. TOLLIVER (02/27/86) OF ROCKFORD.**
- DELIVERY OF 1-15 GRAMS OF COCAINE**
- POSSESSION WITH INTENT TO DELIVER LESS THAN 1 GRAM OF COCAINE**
- ENDANGERING THE LIFE/HEALTH OF A CHILD**

THE CHARGES AGAINST CHRISTOPHER TOLLIVER ARE MERELY ACCUSATIONS AND HE IS PRESUMED INNOCENT UNTIL PROVEN GUILTY IN A COURT OF LAW.
