The Winnebago County Sheriff's Police received complaints from members of the community regarding possible drug trafficking in the 2400 block of 23rd Street, Rockford, IL. The Sheriff's Narcotics Unit initiated an investigation based on those complaints. As a result of that investigation, the Sheriff's Office Narcotics unit executed a search warrant at a residence in the 2400 block of 23rd Avenue on March 3, 2020. During the execution of the warrant, they encountered Terreon D. Ford in a bedroom, laying on top of a loaded handgun. A thorough search of the residence was conducted and deputies located crack cocaine, heroin and a large amount of United States currency. Ford is on parole from the Illinois Department of Corrections for a previous narcotics charge. The Winnebago County States Attorney's Office reviewed the facts of the case and authorized the following charges against the resident, Terreon D. Ford:

- POSSESSION OF A FIREARM BY A GANG MEMBER**

- POSSESSION WITH INTENT TO DELIVER COCAINE (1-15GRAMS)**
- POSSESSION WITH INTENT TO DELIVER HEROIN LESS THAN ONE GRAM**
- POSSESSION OF AMMUNITION WITHOUT REQUISITE FIREARM OWNER'S ID CARD**
- ILLINOIS DEPARTMENT OF CORRECTIONS PAROLE VIOLATION**
