- More than 1 service at the same address will not require additional mileage charges, however additional service fees will be charged for each additional service made at that address.
- Multiple services at multiple addresses will require additional service fees and mileage charges for each additional address.
- There will be no refunds of fees for service or attempted service. Eviction fees will be refunded in full minus the \$5.00 return fee if the cancellation of the eviction is requested a minimum of 1 hour prior to the deputy's arrival for enforcement of the order.
- If necessary, refunds will be mailed at the end of the calendar month.
